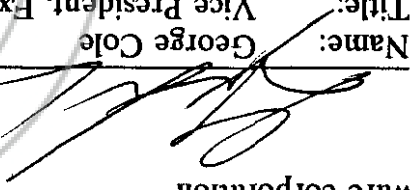
intends to hold the Claims in good standing for the assessment years ending September 1, 1994, and September 1, 1995.

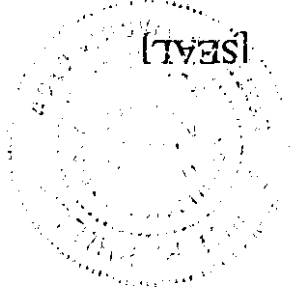

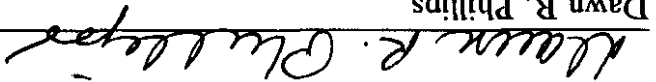


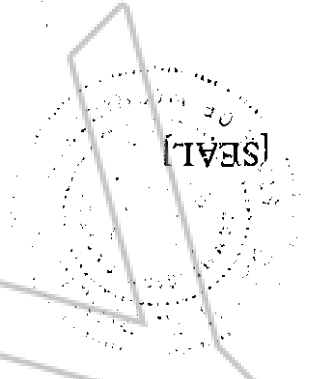
