Corner No. 4, the SW Corner, is a " marked "SW Cor AUGUST 7".

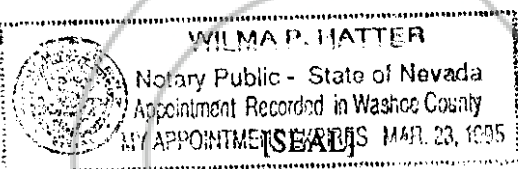
