CERTIFICATE OF LOCATION

Corner No. 4, the SW Corner, is a " marked "SW Cor SEPTEMBER 11".

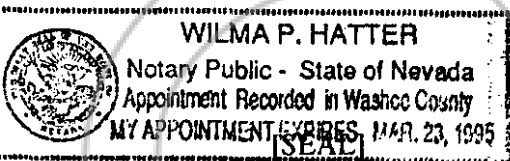
