

NOTICE OF LIEN CLAIM

Schroeder, hereby claims a mechanic's lien pursuant to the provisions of NRS 108.221, et seq., laws of the State of Nevada, in the amount of One Thousand, Five Hundred Eighty Six Dollars and Six Cents (\$1,586.06), a Bechtel T-Shirt, a Bechtel Hat, a Bechtel Buckle, and a R.O.T.P. Hat, on the real property and improvements, located on a portion of Range 51 E., township 34 N., section 36 in Eureka County, Nevada, more commonly known as Newmont Gold Company's Refractory Ore Treatment Plant (ROTP), approximately six miles north of Carlin, Nevada, on the west side of the black top road, whose address is P. 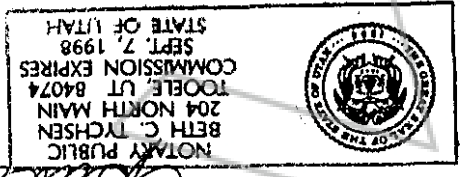
