1. I am the Vice President, Exploration, of Cominco American Resources Incorporated, a Delaware corporation with an address at 15120 East Euclid Avenue, Spokane, Washington 99216, and am personally acquainted with the matters set forth in this affidavit.

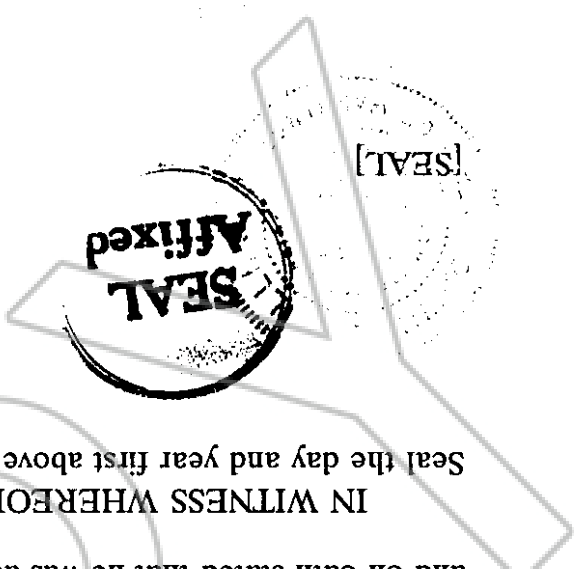
