The claim is approximately 1500 feet long and 600 feet wide, such that 200 feet are claimed in a northerly direction and 1300 feet in a southerly direction from the witnessed point of discovery (witnessed monument of location), and the Notice of Location was posted at the witness location monument on the RK 7 claim at a point 90 feet westerly of the true position of the witnessed monument of location, together with 300 feet on each side of the witnessed monument of location and center line of the Claim. The general course of the lode or vein is from the northerly to the southerly direction.
