& Insurance Agency, Inc. shall be released from any liability hereunder unless a proper action is commenced in a proper court within six (6) months from the recording of the Mechanic's Lien of ELECTRO-TECH, INC., which was recorded on July 27, 1994; and in the event a proper action is commenced within the time required, then Central Bonds & Insurance Agency, Inc. shall remain fully bound on the bond on file herein, in accordance with N.R.S. 108.2413 through N.R.S. 108.2325 inclusive.

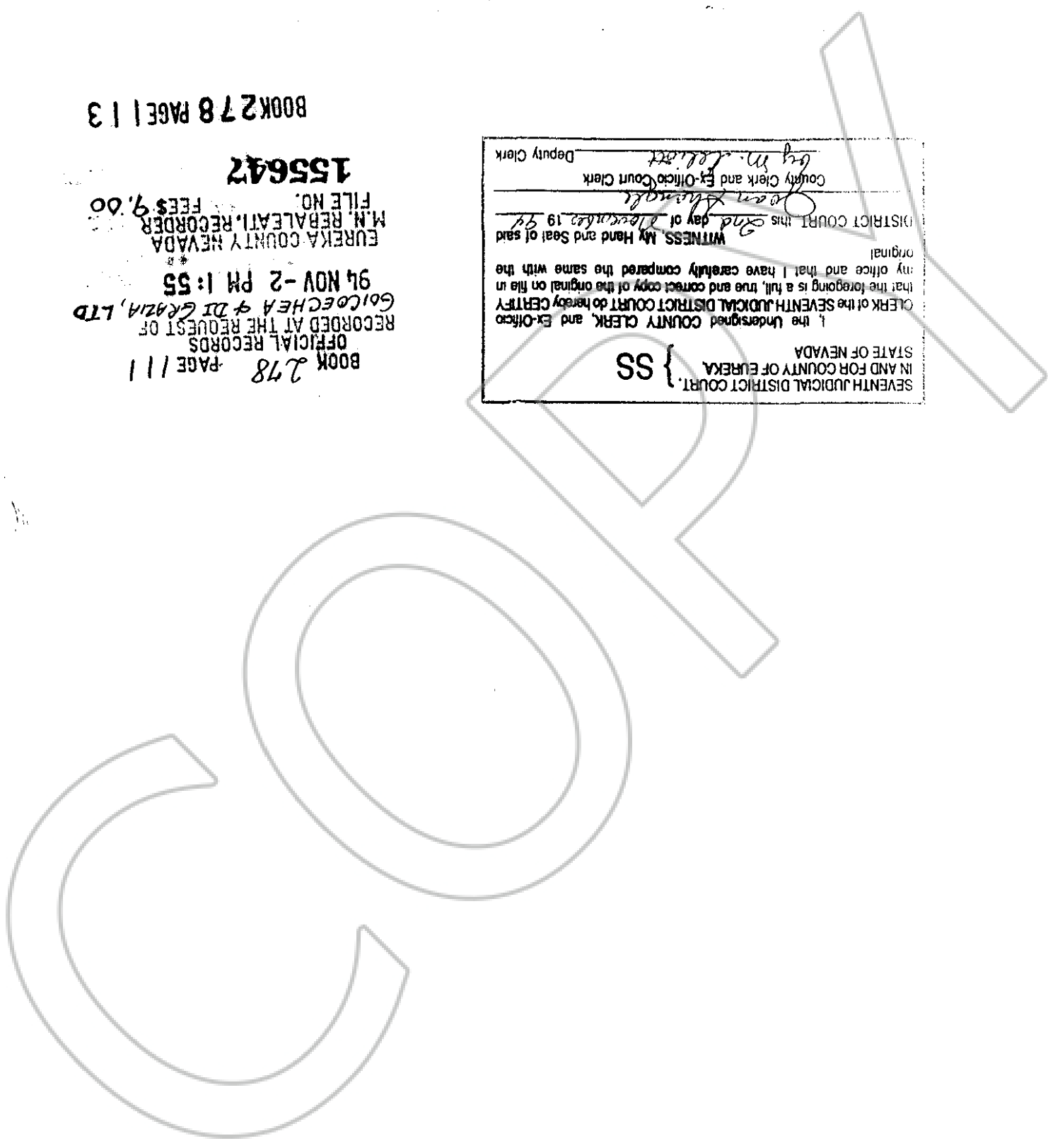
