thence, East	600	to the NE Corner

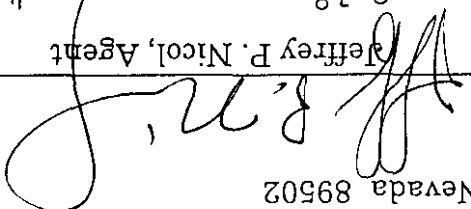
The monumentation and marking of the corners was completed by the 1st day of September 1994
