CERTIFICATE OF LOCATION

NOTICE IS HEREBY GIVEN that BHP Minerals International Exploration Inc., 5330 South 900 East, Salt lake City, a belaware corporation, hereby claims under and pursuant to the laws of the State of Nevada and of the laws of the United States of America the following described LODE MINING CLAIM:

The name of the claim is <u>SB #113</u>.
