**CERTIFICATE OF LOCATION**

NOTICE IS HEREBY GIVEN THAT BHP Minerals International Exploration Inc., 5330 South 900 East, Salt Lake City, a Delaware corporation, hereby claims under and pursuant to the laws of the State of Nevada and of the laws of the United States of America the following described **LODE MINING CLAIM**:

The name of the claim is SB #114.

This claim was located on the 14th day of December, 1994, by posting a Location Notice at the discovery monument found at, on or near the SW End Center of the claim.

The length of the claim is 1400 feet in a NE direction and 20 feet in a SW direction from the monument where the Location Notice is posted, and the width is 300 feet on each side of the center of the vein or lode, comprising in all 1500 feet in length and 600 feet in width, and generally following a SW to NE course.

The exterior boundaries of the claim are distinctly marked by four substantial monuments of stone or wooden posts at least 1-1/2 inches in diameter by four feet in length, set one foot in the ground, one at each corner. The boundaries can be readily traced beginning at corner No. 1, the SW corner:

thence 600 feet SE to the SE corner,  
thence 1500 feet NE to the NE corner,  
thence 600 feet NW to the NW corner,  
thence 1500 feet SW to the SW corner,  
the point of beginning.

The SW corner of the claim, corner No. 1, is found about 6200 feet north and 8300 feet west from the SE corner Sec. 36 T19N R52E (section corner, government marker or permanent monument)

NW/4 of Section 36, Township T9 north, Range 52 east  
SW/4 of Section 36, Township T9 north, Range 52 east  
Mt. Diablo P.M., Eureka County, State of Nevada.

The location work, consisting of the making and filing of maps and the payment of the fee prescribed by NRS 517.040, was completed by the date of recordation of this certificate.
