CERTIFICATE OF LOCATION

NOTICE IS HEREBY GIVEN THAT BHP Minerals International Exploration Inc., 5335 South 900 East, Salt Lake City, a Delaware corporation, hereby claims under and pursuant to the laws of the State of Nevada and of the laws of the United States of America the following described **LODE MINING CLAIM**:

The name of the claim is SB #120.

This claim was located on the 14th day of December 1994, by posting a Location Notice at the discovery monument found at, on or near the SW End Center of the claim.

The length of the claim is 1460 feet in a NE direction and 20 feet in a SW direction from the monument where the Location Notice is posted, and the width is 360 feet on each side of the center of the vein or lode, comprising in all 1560 feet in length and 600 feet in width, and generally following a SW to NE course.

The exterior boundaries of the claim are distinctly marked by four substantial monuments of stone or wooden posts at least 1-1/2 inches in diameter by four feet in length, set one foot in the ground, one at each corner. The boundaries can be readily traced beginning at corner No. 1, the SW corner:

thence 600 feet SE to the SE corner,

thence 1560 feet NE to the NE corner,

thence 600 feet NW to the NW corner,

thence 1500 feet SW to the SW corner,

the point of beginning.

The SW corner of the claim, corner No. 1, is found about 6600 feet north and 8800 feet west from the SE corner Sec. 36 T19N R52E (section corner, government marker or permanent monument)
