CERTIFICATE OF LOCATION

NOTICE IS HEREBY GIVEN that BHP Minerals International Exploration Inc., 5330 South 900 East, Salt Lake City, a Delaware corporation, hereby claims under and pursuant to the laws of the State of Nevada and of the laws of the United States of America the following described **LODE MINING CLAIM**:

The name of the claim is SE #139.

This claim was located on the 14th day of December 1994, by posting a Location Notice at the discovery monument found at, on or near the NE End Center of the claim.

The length of the claim is 1480 feet in a SW direction and 20 feet in a NE direction from the monument where the Location Notice is posted, and the width is 400 feet on each side of the center of the vein or lode, comprising in all 1500 feet in length and 600 feet in width, and generally following a NE to SW course.

The exterior boundaries of the claim are distinctly marked by four substantial monuments of stone or wooden posts at least 1-1/2 inches in diameter by four feet in length, set one foot in the ground, one at each corner. The boundaries can be readily traced beginning at corner No.1, the NW corner:

thence 600 feet SE to the NE corner,
thence 1500 feet SW to the SE corner,
thence 600 feet NW to the SW corner,
thence 1500 feet NE to the NW corner,
the point of beginning.

The NW corner of the claim, corner No.1, is found about 10800 feet north and 13100 feet west from the SE corner Sec.36 T19N R52E (section corner, government marker or permanent monument).

NE 1/4 of Section 27, Township 19 north, Range 52 east
SE 1/4 of Section 22, Township 19 north, Range 52 east
NW 1/4 of Section 27, Township 19 north, Range 52 east
SW 1/4 of Section 27, Township 19 north, Range 52 east
Mt. Diablo P.M., Eureka County, State of Nevada.

The boundaries of said claims were defined as required by law within sixty days from the date of posting of the Notice of Location. The location work, consisting of the making and filing of maps and the payment of the fee prescribed by NRS 517.040, was completed by the date of recordation of this certificate.
