CERTIFICATE OF LOCATION

NOTICE IS HEREBY GIVEN that BHP Minerals International Exploration Inc., 5330 South 9.5 East, Salt Lake Sity, a letaware corporation, hereby claims under and pursuant to the laws of the State of Nevada and of the laws of the United States of America the following describe: LODE MINING CLAIM:

The name of the claim is PB #14?.
