CERTIFICATE OF LOCATION

NOTICE IS HEREBY GIVEN that BHP Minerals International Exploration Inc., 5330 South 900 East, Sait Lake City, a Telaware corporation, hereby claims under and pursuant to the laws of the State of Newada and of the laws of the United States of America the following described LODE MINING CLAIM:

The name of the claim is <u>SB #171</u>.

This claim was located on the <u>13th</u> day of <u>December</u> 1994, by posting a Location Notice at the discovery monument found at, on or near the <u>NE End Center</u> of the claim.
