CERTIFICATE OF LOCATION

NOTICE IS HEREBY GIVEN that BHP Minerals International Exploration Inc., 5336 South 960 East, Salt Lake City, a lelaware corporation, hereby claims under and pursuant to the laws of the State of Nevada and of the laws of the United States of America the following described LODE MINING CLAIM:

The name of the claim is SB #173.

This claim was located on the 13th day of December 1994, by posting a Location Notice at the discovery monument found at, on or near the NE End Center of the claim.

The length of the claim is 1486 feet in a SW direction and 20 feet in a NE direction from the monument where the Location Notice is posted, and the width is 366 feet on each side of the center of the vein or lode, comprising in all 1506 feet in length and 666 feet in width, and generally following a NE to SW course.
