

CERTIFICATE OF LOCATION OF LODE MINING CLAIM

KNOW ALL MEN BY THESE PRESENTS, That the undersigned hereby certifies that:

has located the EJ - 16 Lode Mining Claim on the 6th day of November, 1994 whose dimensions are 1500 feet by 600 feet. By this Declaration and such location, the above named locator(s) claim all veins, lodes, ledges, deposits and surface ground within the boundaries of said claim.

Said claim is a lode it being situated in the above mentioned county and state, and it is distinctly marked on the ground so that its boundaries may be readily traced by four 2" X 2" wooden posts four feet long. Each monument is marked with a scribed metal tag, which states the claim name and number, and the location of the monument with respect to the claim.

Beginning at the NE corner (Cor. No. 1), thence 1500 feet south to the SE corner (Cor. No. 2), thence 600 feet west to the SW Corner (Cor. No. 3), thence 1500 feet north to the NW corner (Cor. No. 4), thence 600 feet east to the Point of Beginning.

To tie this claim to a Public Survey, the NE corner (Cor. No. 1) of this claim lies approximately 3490 feet SOUTH and 7600 feet WEST from the SW Corner of Section 6, Township 18 North, Range 54 East, Mount Diablo Base Line and Meridian.

Said claim is 1500 feet long and 600 feet wide along the surface and claims 20 feet in a North direction and 1480 feet in the opposite direction from the point discovery at which this notice of location is posted together with 300 feet on each side of the point of discovery.
