Declaration and such location, the above named locator(s) claim all
veins, lodes, ledges, deposits and surface ground within the
boundaries of said claim.

Said claim is a lode it being situated in the above mentioned
county and state, and it is distinctly marked on the ground so that
its boundaries may be readily traced by four 2" X 2" wooden posts
four feet long. Each monument is marked with a scribed metal tag,
which states the claim name and number, and the location of the
monument with respect to the claim.

Beginning at the NE corner (Cor. No. 1), thence 1500 feet
