

NOTICE OF LIEN CLAIM

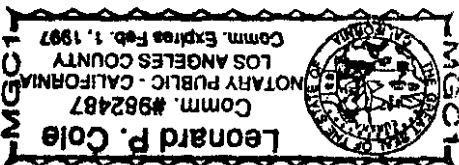
