I, Scott R. Holmes, being first duly sworn, do depose and state as follows:

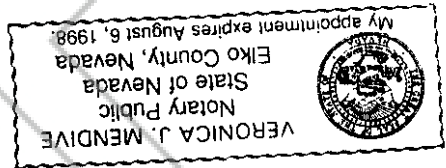
