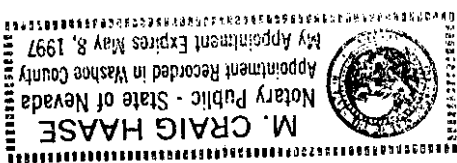
Affiant, first being sworn and under the penalties of perjury, deposes and says:
