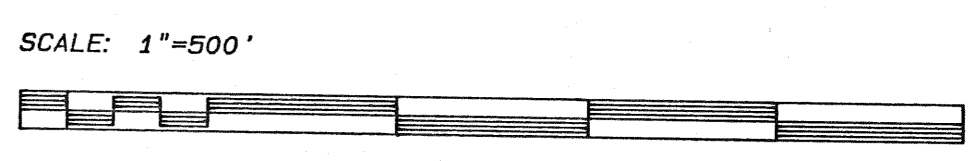
NOTES:
