The work of location consisted of making the maps provided in NRS 517.040.

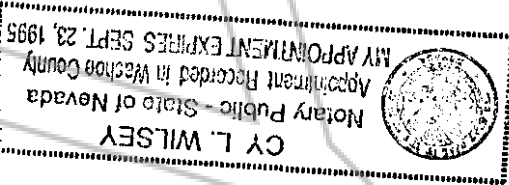
