Corner No. 4, the S.W. Corner, is a 2" x 2" x 4' marked "S.W. CORNER TWT 94"

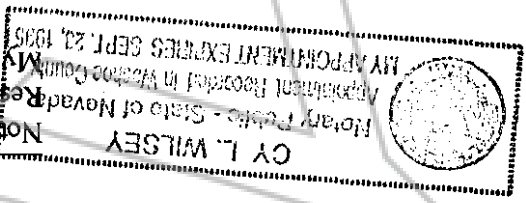
