The undersigned hereby certifies that he has caused to be located the Kobeh 1829 Lode Mining Claim on the 26th day of January, 1995.

NE ¼ of Section 32, Township 21N, Range 51E  
Mount Diablo Base Line and Meridian, Eureka County, Nevada.

To tie this claim to the public survey, begin at the NW corner of section 32, T22N, R51E, MD Base Line and Meridian and travel 1500' S and 1800' E to the NW corner of the claim.

The Claim is approximately 1500 feet long and 600 feet wide , such that 20 feet is claimed in a southerly direction and 1480 feet in a northerly direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the Claim. The general course of the lode or vein is north-south.

The boundaries of this claim are monumented with 2 inch by 2 inch by 4½ foot long wooden posts. Each monument is marked with a scribed metal tag which states the claim name and number and the location of the monument with respect to the claim.

To locate the monuments, begin at the northeast corner of the claim and travel:

1500 feet South to the southeast corner, thence  
600 feet West to the southwest corner, thence  
1500 feet North to the northwest corner, thence  
600 feet East to the northeast corner of the claim.

The work of location consisted of making a claim map as provided in NRS 517.040, a copy of which is filed with the County Recorder.
