CERTIFICATE OF LOCATION

NOTICE IS HEREBY GIVEN that **BHP Minerals International Exploration Inc.**, 5330 South 900 East Suite 200, Salt Lake City, UT 84117 a Delaware corporation, hereby claims under and pursuant to the laws of the State of Nevada and of the laws of the United States of America the following described **LODE MINING CLAIM**:

The name of the claim is POS 163.

This claim was located on the 23rd day of March 1995, by posting a Location Notice at the discovery monument found at, on or near the east end center of the claim.

The length of the claim is 1400 south in a south direction and 100 feet in a north direction from the monument where the Location Notice is posted, and the width is 300 feet on each side of the center of the vein or lode, comprising in all 1500 feet in length and 600 feet in width, and generally following a north-south course.

The exterior boundaries of the claim are distinctly marked by four substantial monuments of stone or wooden posts at least 1-1/2 inches in diameter by five feet in length, set one foot in the ground, one at each corner. The boundaries can be readily traced beginning at corner No.1, the northwest corner:  
thence 1500 feet south to corner #2 the NW corner,  
thence 600 feet east to corner #3 the SW corner,  
thence 1500 feet north to corner #4 the SE corner,  
thence 600 feet west to corner #1,  
the point of beginning.

The NW corner of the claim, corner No.1, is found about 5300 feet west and 4050 feet south from the NE corner Section 11, T44N R55E. (section corner, government marker or permanent monument)

SE/4 of Section 10, Township 44 north, Range 55 east  
NW/4 of Section 14, Township 44 north, Range 55 east  
SW/4 of Section 11, Township 44 north, Range 55 east  
Mt. Diablo P.M., Elko County, State of Nevada.

The boundaries of said claims were defined as required by law within sixty days from the date of posting of the Notice of Location. The location work, consisting of the making and filing of maps and the payment of the fee prescribed by NRS 517.040, was completed by the date of recordation of this certificate.
