The general course of the claim is North to South.

The boundaries of this claim are monumented with 2 inch by 2 inch by 4 foot long wooden posts. Each monument is marked with a scribed metal tag, which states the claim name and number, and the location of the monument with respect to the claim.

The corner monuments were erected within 60 days of the notice of location. To locate the monuments, begin at the northeast corner of the claim and travel:

1500 feet South to the southeast corner, thence 600 feet West to the southwest corner, thence 1500 feet North to the northwest corner, thence 600 feet East to the northeast corner of the claim.
