

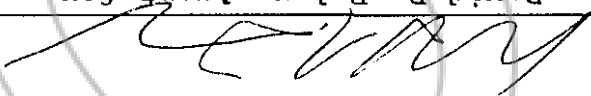
NOTICE OF REMONUMENTATION
