

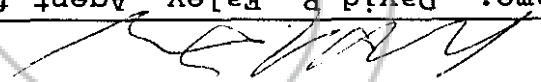
NOTICE OF REMONUMENTATION

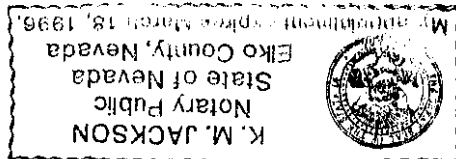
