To tie this claim to the Public Survey, begin at the Northwest corner of Section 1, Township 22 North, Range 51 East, Mount Diablo Base and Meridian, thence South, approximately 1,275 feet and East, approximately 7,889 feet to the Northeast corner (Cor. No. 1) of this claim.

We (or I) claim 1,500.00 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1,450.00 feet from the location monument in a Northeasterly direction and 50 feet in a Southwesterly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 4 inch x 4 inch x 4 foot long wooden post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:

Beginning at the Northeast Corner (Corner No. 1),

thence, S. 27° 58' 28" W., 1,500.00 feet to the Southeast Corner (Cor. No. 2),
thence, N. 74° 14' 30" W., 600.00 feet to the Southwest Corner (Cor. No. 3),
thence, N. 27° 58' 28" E., 1,500.00 feet to the Northwest Corner (Cor. No. 4),
thence, S. 74° 14' 30" E., 600.00 feet to the Northeast Corner (Cor. No. 1),

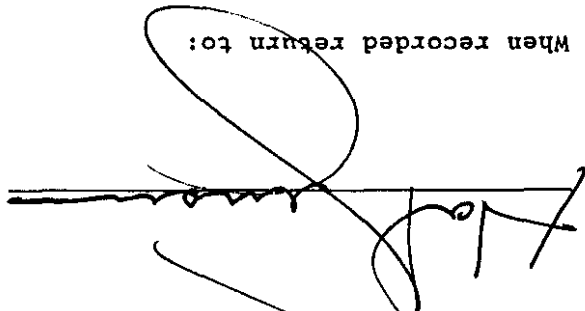
the point and place of beginning.
