not, by acceptance of rentals, or in any other manner, recognize the same as a valid or

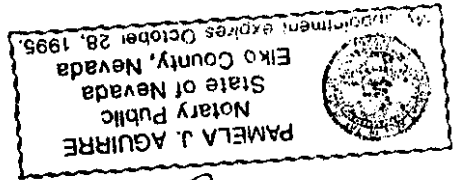
