

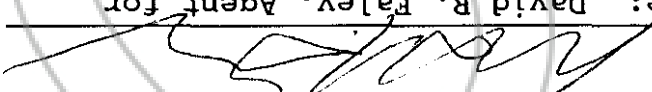
NOTICE OF REMONUMENTATION

This Notice does not constitute an amendment to the lode mining claims listed on the attached Exhibit A, and is made without any waiver of any rights previously acquired with respect to those claims.

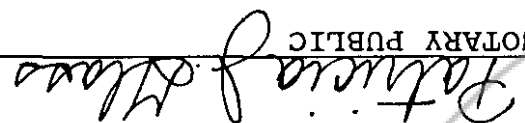

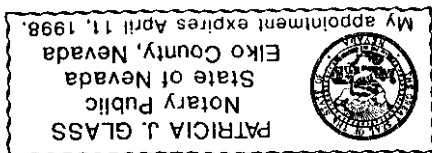
