

QUITCLAIM AND RELINQUISHMENT

THIS QUITCLAIM AND RELINQUISHMENT, made effective the 18th day of September, 1995, is from NEWMONT EXPLORATION LIMITED, a Delaware corporation ("Grantor"), whose address is 1700 Lincoln Street, Denver, Colorado 80203, to LYLE F. CAMPBELL, individually, and as Sole Trustee for THE LYLE F. CAMPBELL TRUST, whose address is P. O. Box 7377, Reno, Nevada 89510, (hereinafter referred to as "Grantee").

RECITALS

Newmont Exploration Limited entered into an Exploration Agreement and Option to Purchase (the "Agreement") with Lyle F. Campbell, individually, and as Sole Trustee for the Lyle F. Campbell Trust, dated October 11, 1993, a memorandum of which was recorded October 13, 1993, in Book 253 at pages 152-157 of the Official Records of Eureka County, Nevada, covering certain rights in and to those certain unpatented mining claims described in Exhibit A attached hereto and by this reference made a part hereof (the "Mineral Prospect"), sometimes known as the Maggie Creek Mineral Prospect.

Effective September 18, 1995, Newmont Exploration Limited has terminated the Agreement with Grantor, and now desires to deliver a relinquishment of the Agreement and the Mineral Prospect as provided in Section 14(a) thereof.

WITNESSETH:

Grantor, pursuant to Section 14(a) of the Agreement, hereby relinquishes the Agreement effective September 18, 1995, and quitclaims, releases and relinquishes unto Grantee, Grantee's successors and assigns, all right, title and interest of Grantor in and to the Mineral Prospect.

TO HAVE AND TO HOLD the same unto said Grantee, Grantee's successors and assigns forever.

THIS QUITCLAIM AND RELINQUISHMENT IS MADE WITHOUT WARRANTY OF ANY KIND, EXPRESS, IMPLIED OR STATUTORY.

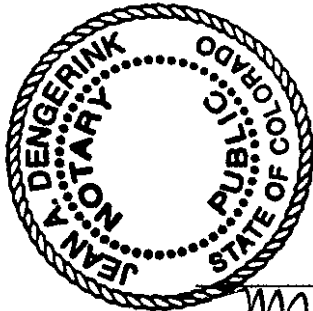

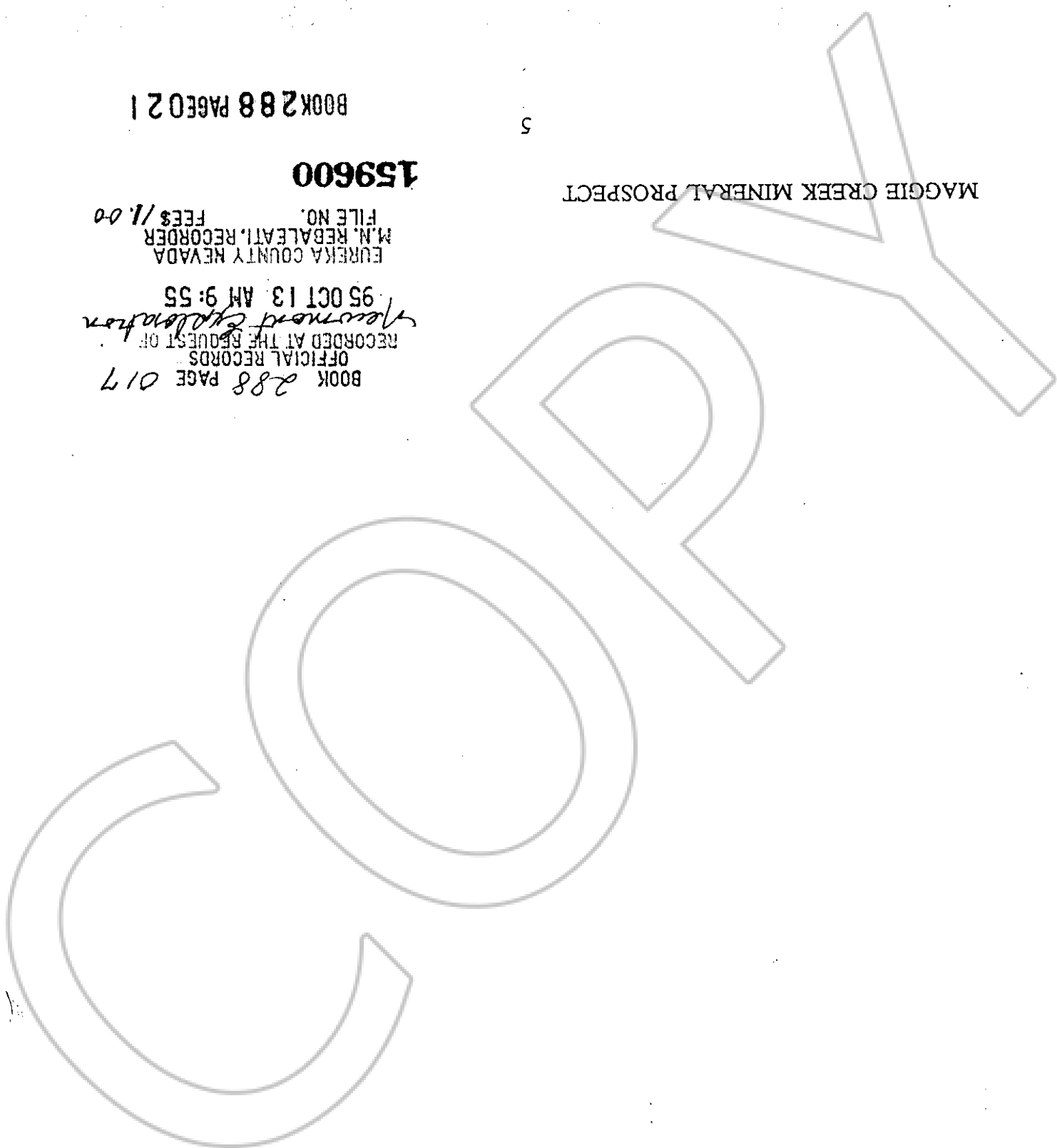
