

Transfer of Title to Overriding Royalties

Pursuant to the Decree and Permanent Orders dated June 16, 1994 in the case titled In Re the

Marriage of Randy L. Chamberlain and Connie J. Chamberlain, Case No. 93 DR 1106 in the District Court,

County of Jefferson, State of Colorado, a certified copy of which is attached hereto, which provides that

one-half of its interest in any overriding royalties to oil and gas leases in the counties of Elko, Eureka, White

Pine, Nye and Lincoln in the State of Nevada which overriding royalties have been assigned or will be

assigned by Phillips Petroleum Company or The Anschutz Corporation to Blue Eagle Exploration, Inc. or

to Randy L. Chamberlain n/k/a Randall L. Etherington.

This Transfer of Title to Overriding Royalties is intended to allow Phillips Petroleum Company to

assign Connie J. Chamberlain's interest in the overriding royalties, which she received pursuant to the Decree

and Permanent Orders, directly to Connie J. Chamberlain.

This Transfer of Title to Overriding Royalties is executed by the Clerk of the Jefferson County

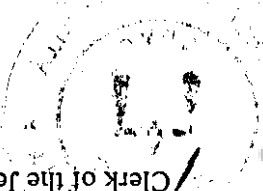
