2. X-Cal Resources (USA) Inc. claims and owns the unpatented lode mining claims (the "Claims"), located in Eureka County, Nevada, described in the list attached hereto as Attachment I. 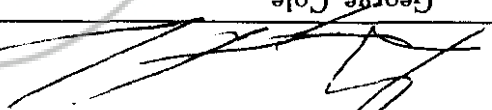

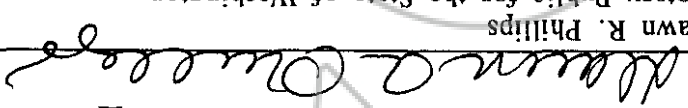

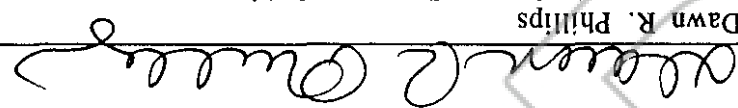
