QUITCLAIM DEED

THIS INDENTURE, Made this 16th day of October, 1995, between THE ATCHISON, TOPEKA AND SANTA FE RAILWAY COMPANY, a Delaware corporation, hereinafter referred to as "Santa Fe", and EUREKA COUNTY, Grantee.

WITNESSETH, that said Santa Fe, for a valuable consideration, the receipt of which is hereby acknowledged, does by these presents REMISE, RELEASE AND QUITCLAIM unto the said Grantee all of the Santa Fe's right, title and interest, if any, in and to the following described real property:

A PARCEL OF LAND IN THE COUNTY OF EUREKA, STATE OF NEVADA, LYING IN THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION 35, TOWNSHIP 32 NORTH, RANGE 51 EAST, MOUNT DIABLO MERIDIAN, BEING THAT PORTION OF LAND WITHIN SAID SECTION, NOW AND FOR MANY YEARS PAST, OCCUPIED BY THE "PALISADE CEMETERY", AND MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT CORNER # 1 OF SAID PARCEL, THE WESTERLY FENCE CORNER OF THE DESCRIBED CEMETERY SITE, FROM WHICH THE QUARTER SECTION CORNER COMMON TO SECTIONS 35 AND 36, OF SAID TOWNSHIP, BEARS SOUTH 50°44'EAST (BEARINGS ASSUMED FOR PURPOSES OF THIS DESCRIPTION), 147.7 FEET;

THENCE ALONG SAID FENCELINE NORTH 34°51'EAST, 161.5 FEET TO A FENCE CORNER AT THE NORTHERLY CORNER OF SAID CEMETERY SITE;

THENCE ALONG SAID FENCELINE SOUTH 57°38'EAST, 25.39 FEET TO A POINT ON THE EASTERLY SECTION LINE OF SAID SECTION 35;

THENCE ALONG SAID SECTION LINE SOUTH 0°10'EAST, 190.17 FEET TO A POINT ON THE SOUTHWESTERLY FENCELINE OF SAID CEMETERY SITE;

THENCE ALONG SAID FENCELINE NORTH 58°04'WEST, 134.67 FEET TO CORNER #1, THE POINT OF BEGINNING FOR THE PARCEL HEREIN DESCRIBED.

THE "CEMETERY SITE" CONTAINS AN AREA OF 0.296 OF AN ACRE, MORE OR LESS.
