Corner No. 4, the NW Corner, is a " marked "NW" "NW"

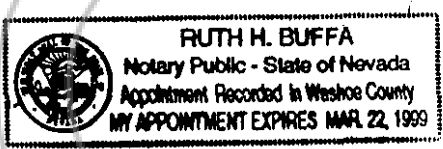
