 - SE 1/4 of Section 2, Township 25 N., Range 52 E.
 - SW 1/4 of Section 2, Township 25 N., Range 52 E.
- Mount Diablo Base Line and Meridian, Eureka County, Nevada.

To tie this claim to the public survey, begin at the USBM 6912 in the NW 1/4 of
Section 36, T. 26 N., R. 52 E., Mount Diablo Base Line and Meridian and travel:

4,800 feet South
and
1,700 feet West

to the northeast corner of the claim.

The claim is 1500 feet long and 600 feet wide, such that 10 feet is claimed in an
East direction and 1490 feet is claimed in a West direction from the location monument,
together with 300 feet on each side of the monument of location and center line of the claim.
The general course of the claim is East to West.

The boundaries of this claim are monumented with 2 inch by 2 inch by 4 foot long wooden
posts. Each monument is marked with a scribed metal tag, which states the claim name and
number, and the location of the monument with respect to the claim.

The corner monuments were erected within 60 days of the notice of location.
To locate the monuments, begin at the northeast corner (No. 1) of the claim and travel:

- 600 feet South to the southeast corner (No. 2), thence
- 1500 feet West to the southwest corner (No. 3), thence
- 600 feet North to the northwest corner (No. 4), thence
- 1500 feet East to the northeast corner (No. 1) of the claim.

The location work included the making of a claim map as provided in the regulations, a copy
of which is filed with the county recorder and is herein incorporated by this reference.
