

MEMORANDUM OF MINING VENTURE AGREEMENT

This Memorandum Of Mining Venture Agreement (this "Memorandum") dated effective as of September 29, 1995 (the "Effective Date") is by and between Atlas Corporation, a Delaware corporation whose address for these purposes is 370 17th Street, Suite 3150, Denver, Colorado 80202, its two wholly owned subsidiaries, Atlas Precious Metals Inc. and Atlas Gold Mining Inc., both of which are Nevada corporations whose addresses for these purposes are the same as the address of Atlas Corporation set forth above (all of the foregoing corporations are collectively referred to hereinafter as "ATLAS") and Granges (U.S.) Inc., a Nevada corporation whose address for these purposes is 350 S. Rock Blvd., #E, Reno, Nevada 89502 ("GRANGES"). ATLAS and GRANGES are sometimes collectively referred to hereinafter as the "Participants."

1. Purposes of Memorandum. This Memorandum is executed and recorded for purposes of affording notice to all third persons and the public generally of a Mining Venture Agreement of even date herewith between ATLAS and GRANGES (the "Mining Venture Agreement") affecting the Properties, Assets, Area of Interest and Atlas Mill Complex (all as hereinafter defined). The Mining Venture Agreement contains numerous terms and conditions, only some of which are reflected in this Memorandum. This Memorandum is not intended to and shall not amend, modify, alter, limit or abrogate in any way any of the terms or provisions of the Mining Venture Agreement. In the event of any conflict or inconsistency between the terms and conditions of this Memorandum and those set forth in the Mining Venture Agreement, the provisions of the Mining Venture Agreement shall in all instances control, prevail and govern.

2. Definitions. As used in this Memorandum, the following terms and phrases shall have the meanings assigned below:

2.1 "Access" shall mean the right to cross over, on or beneath the surface of property as a means of ingress and egress to and from other property for vehicles, conveyors or other materials transport systems, pipelines, utility lines, canals, ditches, and other forms of transportation or movement of people, matter, or things, and the right to construct, maintain and close roads, underground passageways, and other routes and ways, and to construct, maintain and remove equipment and facilities for such uses.

2.2 "Area of Interest" means the entire area encompassed within the exterior boundaries of the Properties and the Atlas Mill Complex.

2.3 "Assets" means the Properties, Products and all other real and personal property, tangible and intangible, held for the benefit of the Participants under the Mining Venture Agreement.

2.4 "Atlas Mill Complex" means the surface estate only of both the patented lode and mill site claims and the unpatented mill site claims described in Part 1 of Exhibit A,

together with all facilities, infrastructure, plants, tailings, slag, materials, stockpiles, dumps and other improvements and appurtenances on such surface estate.

2.5 "Development" means all preparation for the removal and recovery of Products, including the construction or installation of a mill, leaching facilities or any other improvements to be used for the mining, handling, milling, processing or other beneficiation of Products.

2.6 "Exploration" means all activities directed toward ascertaining the existence, location, quantity, quality or commercial value of deposits of Products.

2.7 "Mining" means the mining, extracting, producing, handling, milling or other processing of Products.

2.8 "Operations" means the activities carried out under the Mining Venture Agreement.

2.9 "Participant" and "Participants" mean the persons or entities that from time to time have Participating Interests under the Mining Venture Agreement.

2.10 "Participating Interest" means the percentage interest representing the operating ownership interest of a Participant in Assets, and all of the rights and obligations arising under the Mining Venture Agreement, as such interests may from time to time be adjusted.

2.11 "Products" means all ores, minerals and mineral resources produced from the Properties under the Mining Venture Agreement.

2.12 "Properties" means those interests in real property described in Parts 1-4 of Exhibit A to this Memorandum and all other interests in real property within the Area of Interest

which are acquired and held subject to the Mining Venture Agreement. The Properties include, without limitation, the entire mineral estate in and underlying the Atlas Mill Complex, as described in Part 1 of Exhibit A, together with: (i) the right of Access across the surface of the Atlas Mill Complex and the right to use and consume so much of the surface of the Atlas Mill Complex as

may be reasonably necessary or convenient to the Exploration, Development and Mining of such mineral estate, by whatever method is now known or subsequently developed, including without limitation by open pit or surface mining methods; and (ii) the right to use the surface of the Atlas Mill Complex for the conduct of Operations, including without limitation the treatment, processing, milling, leaching or beneficiation of Products and the disposal of tailings, overburden, waste, rock and other by-products and materials. Subject to the preceding sentence, the Atlas Mill Complex (as defined in Section 2.4 above) is expressly excluded from the Properties.

Notwithstanding the foregoing, the Venture's right to use the surface of the Atlas Mill Complex shall not unreasonably interfere with ATLAS' operations at the Atlas Mill Complex, its use of the

existing access road to the Atlas Mill Complex or ATLAS' existing haul road and ATLAS shall have the right to conduct such operations as it deems necessary at the Atlas Mill Complex.

2.13 "Transfer" means to sell, grant, assign, encumber, pledge or otherwise commit or dispose of.

2.14 "Venture" means the business arrangement of the Participants under the Mining Venture Agreement.

3. Purposes of Mining Venture Agreement. GRANGES and ATLAS have entered into the Mining Venture Agreement for purposes of conducting Exploration, Development and, if warranted, Mining of Products within the Properties and Area of Interest. The Mining Venture Agreement shall be the exclusive means by which ATLAS and GRANGES, or either of them, engage in any activity within the Area of Interest, acquire or Transfer interests in real property with the Area of Interest, engage in marketing of Products (to the extent permitted by the Mining Venture Agreement), or engage in any other lawful purposes related or incidental to the foregoing.

4. Term. The Mining Venture Agreement shall be effective as of the Effective Date and shall continue for a term of twenty years and so long thereafter as Products are produced from the Properties, unless the Mining Venture Agreement is earlier terminated in accordance with its terms.

5. Participating Interests. Each of GRANGES and ATLAS shall initially hold a fifty percent Participating Interest in the Properties and Assets. Such Participating Interests may change from time to time in accordance with the terms and conditions of the Mining Venture Agreement. Such changes in the Participants' Participating Interests may or may not be reflected of record. Title to the Properties and Assets shall be held in the name of GRANGES, subject to the rights of the Participants under the Mining Venture Agreement.

6. No Partnership. Nothing contained in this Memorandum or the Mining Venture Agreement shall be deemed to constitute either Participant the partner of the other, nor, except as otherwise expressly provided in the Mining Venture Agreement, to constitute either Participant the agent or legal representative of the other, nor to create any fiduciary relationship between them. Notwithstanding the foregoing, the Participants have agreed that their relationship shall constitute a tax partnership within the meaning of Section 761(a) of the United States Internal Revenue Code of 1986, as amended.

7. Restrictions on Transfers. The Mining Venture Agreement contains certain prohibitions, restrictions and limitations on the rights of GRANGES and ATLAS to Transfer any of their respective rights, titles or interests in or to the Mining Venture Agreement, Participating Interests, the Properties, the Assets, or the Atlas Mill Complex. Such restrictions include, but are

not limited to, certain preferential rights of purchase, as well as the requirement that transferees assume certain obligations and liabilities in writing.

8. ATLAS' Liabilities and Obligations. The liabilities and obligations of ATLAS arising under the Mining Venture Agreement are the joint and several liabilities and obligations of each of Atlas Corporation, Atlas Precious Metals Inc. and Atlas Gold Mining Inc.

9. Toll Milling Arrangement. Pursuant to the Mining Venture Agreement, the Venture has certain rights to have ATLAS mill the Venture's Products at the Atlas Mill Complex on a toll milling basis. Any Transfer by ATLAS of any right, title or interest in or to the Atlas Mill Complex shall be subject to such contractual rights of the Venture, as well as certain other restrictions, limitations and requirements set forth in the Mining Venture Agreement.

10. Reserved Royalty. In accordance with the terms and conditions of the Mining Venture Agreement, ATLAS will be entitled to receive a two percent Net Smelter Returns royalty (as defined in the Mining Venture Agreement) on Products produced by the Venture from certain portions of the Properties that are not presently burdened by any royalty on production, as more particularly described in Parts 1 and 3 of Exhibit A. The production royalty payable to ATLAS under the Mining Venture Agreement shall survive any relinquishment by ATLAS of its Participating Interest.


11. Access. Pursuant to the terms of the Mining Venture Agreement, ATLAS has granted and assigned to the Venture and GRANGES the following: (i) rights of Access across any and all properties owned or controlled by ATLAS outside of the Properties, to the extent such Access is reasonably necessary or convenient for the conduct of operations upon the Properties or the exercise of any right under the Mining Venture Agreement; and (ii) the same rights of Access across properties in which ATLAS has contractually reserved or otherwise acquired such rights of Access. ATLAS has reserved the reasonable right of Access across the Properties in order that it may continue to conduct exploration, development, mining, processing and reclamation operations on land adjacent to or nearby the Properties or at the Atlas Mill Complex, provided that the exercise of such rights of Access shall not (except with respect to ATLAS' use of the existing access road to the Atlas Mill Complex and ATLAS' existing haul road) unreasonably interfere with or cause delays to operations conducted upon the Properties pursuant to the Mining Venture Agreement.

12. Reservation of Atlas Mill Complex. Subject to certain rights of the Venture and GRANGES set forth in the Mining Venture Agreement and in this Memorandum, ATLAS has reserved the Atlas Mill Complex unto itself.


13. Acquisitions And Transfers Within Area of Interest. The acquisition or Transfer by any of the Participants of any right, title or interest in or to any real property within the Area of Interest shall be subject to certain restrictions, limitations, prohibitions, and requirements set forth in the Mining Venture Agreement.

14. Additional Terms. The Mining Venture Agreement contains numerous additional terms and conditions not contained in this Memorandum that affect the rights and obligations of GRANGES and ATLAS with respect to the Properties, the Assets, the Area of Interest, the Atlas Mill Complex, and their respective Participating Interests. A copy of the Mining Venture Agreement will be made available to any interested party demonstrating in writing a bona fide reason to review same. Such copy will be made available at either the ATLAS or GRANGES offices identified above.





Subject to the preceding sentence, the Atlas Mill Complex is expressly excluded from the Properties. Notwithstanding the foregoing, the Venture's right to use the surface of such claims shall not interfere unreasonably with ATLAS' operations at the Atlas Mill Complex, its use of the existing access road to the Atlas Mill Complex or ATLAS' existing haul road and ATLAS shall have the right to conduct such operations as it deems necessary at the Atlas Mill Complex.
