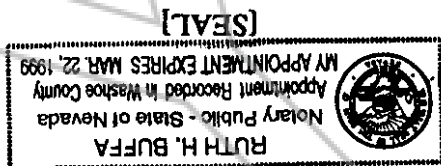
Corner No. 1, the NE Corner, is 2"X2"X4" Wood marked "NE Corner SSV #37".
