

CERTIFICATE OF LOCATION

Corner No. 4, the NW Corner, is 2"X2"X4" Wood marked "NW Corner SSV #87".

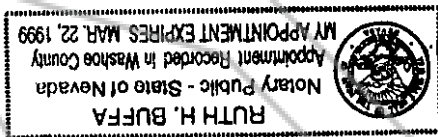
