Corner No. 4, the NW Corner, is 2" X 2" X 4" Wood marked "NW Corner SSV # 163."

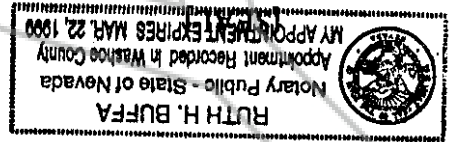
