 Corner No. 4, the NW Corner, is 2"X2"X4' Wood marked "NW Corner SSV # 172".

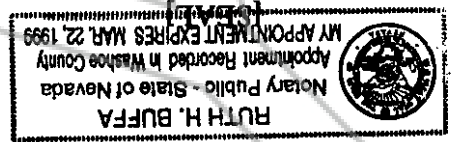
