KNOW ALL MEN BY THESE PRESENTS:

Demand, sue for, collect, and receive all such sums of

money, debts, dues, accounts, legacies, bequests, interest,

dividends, annuities, and demands whatsoever, as are now or shall

hereafter become due, owing, payable, or belonging to me, and

have, use, and take all lawful ways and means in my name, or

otherwise, for the recovery thereof by attachment, arrest, or

otherwise, and to compromise and agree for the same, and

discharge for the same for me and in my name to make and deliver;

to contract for, purchase, receive, and take lands, tenements,

1 and hereditaments, and accept the seisin and possession of all  
 2 lands, and all deeds and other assurance in the law thereof, and  
 3 to lease, let, sell, release, convey, mortgage, convey by way of  
 4 deed of trust, and hypothecate lands, tenements, and  
 5 hereditaments upon such terms and conditions, and under such  
 6 covenants as they shall think fit; also to bargain for, buy,  
 7 sell, mortgage, hypothecate, and in any way and every way and  
 8 manner deal in and with goods, merchandise, choses in action, and  
 9 other property in possession or in action, and to do every kind  
 10 of business of what nature or kind soever; and also for me and in  
 11 my name, and as my act and deed to make, sign, seal, execute,  
 12 acknowledge, and deliver deeds, leases and assignments of lease,  
 13 covenants, indentures, agreements, mortgages, deeds of trust and  
 14 reconveyances thereunder, bills of lading, bills, bonds, notes,  
 15 stock certificates, drafts and checks, receipts, evidences of  
 16 debt, release and satisfaction of mortgage, judgments, and other  
 17 debts, and such other instruments in writing of whatever kind and  
 18 nature as may be necessary, convenient, or proper in the  
 19 premises, including assignments of accounts receivable, notices  
 20 of the expected assignment of such accounts and cancellation of  
 21 such notices; also, in case of loss by fire, or otherwise, to  
 22 adjust insurance losses.

6 power to act with respect to the care of my person in the event

7 that I should become incapacitated or otherwise unable to make

8 ordinary or extraordinary medical decisions for myself. I

9 expressly grant this power contingent upon my incapacity, subject

10 to withdrawal in the event that I should regain my capacity to

11 act.

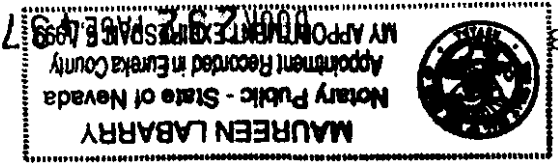
