CERTIFICATE OF LOCATION - LODE MINING CLAIM

That American Carbonate Rock Inc., by and through their lawful and authorized agent, Barry K. Bradshaw, gives notice that he/they claims the land described below as a lode mining claim pursuant to the laws of the United States of America and the State of Nevada, and in making such claim and establishing his/their rights, states and certifies as follows:

The claim is 1,500 feet long and 600 feet wide, such that 1,490 feet is claimed in a N 45° E direction and 10 feet in a S 45° W direction from the discovery monument, at which the Location Notice is posted, lengthwise of the claim, together with 300 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode or vein is Northeasterly and Southwesterly as nearly as can be determined.

5. The location work consisted of making maps as provided by NRS 517.040.
