The claim is 1,500 feet long and 600 feet wide, such that 1,490 feet is claimed in a southerly direction and 10 feet in a northerly direction from the discovery monument, at which the location notice is posted, lengthwise of the claim, together with 300 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode or vein is northerly and southerly as nearly as can be determined.
