CERTIFICATE OF LOCATION - LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

That American Carbonate Rock Inc., by and through their lawful and authorized agent, Barry K. Bradshaw, gives notice that he/they claims the land described below as a lode mining claim pursuant to the laws of the United States of America and the State of Nevada, and in making such claim and establishing his/their rights, states and certifies as follows:

1. The name of the claim is ACR 255.

The general course of the lode or vein is Northerly and Southerly as nearly as can be determined.
