**CERTIFICATE OF LOCATION OF LODE MINING CLAIM**

TO ALL WHOM IT MAY CONCERN:

The undersigned as Agent for Carl Pescio, owner, hereby certifies that he has located the MH 4 lode mining claim in Section(s) 3, 10, Township 26 North, Range 52 East, Mount Diablo Base and Meridian, in the Unknown Mining District, County of Eureka, State of Nevada.

The claim is 1500 feet in length and 600 feet in width, and 25 feet is claimed in a West direction and 1475 feet is claimed in a East direction from the location monument upon which the Notice of Location is posted, together with 300 feet on each side of the center of the claim. The general course of the lode deposit and premises is from the East to the West.

The position of each corner of this claim is shown on the mining claim map recorded herewith. The monument position and markings on each corner and side center monument is as follows:

The monumentations and marking of the above described corners on the ground was completed within 60 days from the date of posting and the notice of location; and the location work consisted of making and recording of duplicate claim maps and payment of the fees prescribed by NRS 517.040.
