**CERTIFICATE OF LOCATION OF LODE MINING CLAIM**

TO ALL WHOM IT MAY CONCERN:

The undersigned as Agent for Carl Pescio, owner, hereby certifies that he has located the MH 10 lode mining claim in Section(s) 10, Township 26 North, Range 52 East, Mount Diablo Base and Meridian, in the Unknown Mining District, County of Eureka, State of Nevada.

The claim is 1500 feet in length and 600 feet in width, and 25 feet is claimed in a West direction and 1475 feet is claimed in a East direction from the location monument upon which the Notice of Location is posted, together with 300 feet on each side of the center of the claim. The general course of the lode deposit and premises is from the East to the West.
