**CERTIFICATE OF LOCATION OF LODE MINING CLAIM**

TO ALL WHOM IT MAY CONCERN:

The undersigned as Agent for Carl Pescio, owner, hereby certifies that he has located the MH 31 lode mining claim in Section(s) \_\_\_\_\_, Township 26 North, Range 52 East, Mount Diablo Base and Meridian, in the Unknown Mining District, County of Eureka, State of Nevada.
