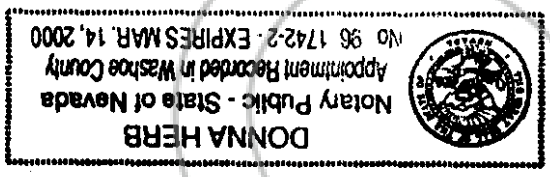


NOTICE OF INTENT TO HOLD
